### Outcome 1

Explain legislation related to health and safety, and supporting documents, applicable to an extractive site.

### Performance criteria

- 1.1 The Health and Safety at Work Act is explained in terms of requirements for management practices and systems at an extractive site.
- Range includes but is not limited to – reasonably practicable, duties and their application for a person conducting a business or undertaking (PCBU) and officers and workers, notifiable events, inspectors, offences and penalties
- 1.2 Health and safety regulations are explained in terms of requirements for management practices and systems at an extractive site.
- Range includes– HSW (Mining Operations and Quarrying Operations) Regulations 2016; HSW (General Risk and Workplace Management) Regulations 2016, HSW (Worker Engagement, Participation, and Representation) Regulations 2016; includes but is not limited to – workplace facilities, stress, hazards, principal hazard management plans, principal control plans, statutory positions, worker participation, worker health, electrical and mechanical engineering, emergency management.
- 1.3 Supporting health and safety documents applicable to an extractive site are identified and described in terms of their place in the hierarchy of legislation and their relevance to management practices and systems at an extractive site.
- Range includes but is not limited to – approved codes of practice, best practice guidelines, standards, mining and quarrying industry documents, relevant documents from other industries (where relevant)
- 1.4 The HSNO Act 1996 and the HSNO Regulations 2001 are explained in terms of their relevance to safety management practices and systems at an extractive site.
- Range approved handlers, controlled substance licence (CSL), safety data sheets (SDS), penalties and liabilities, exposure protection, security; Regulations include – Hazardous Substances (Classes 1 to 5 Controls), Hazardous Substances (Identification), Hazardous Substances (Packaging), Hazardous Substances (Disposal), Hazardous Substances (Emergency Management), Hazardous Substances (Tracking).
