Guidance Information

- 2 Evidence presented for assessment against this unit standard must be consistent with safe working practices and be in accordance with applicable service information, and company and legislative requirements. This includes the knowledge and use of suitable tools and equipment.
- 3 Legislation, regulations and/or industry standards relevant to this unit standard include but are not limited to the current version of the Health and Safety at Work Act 2015; and any subsequent amendments and replacements.
- 4 Definitions
Company requirements refer to instructions to staff on policy and procedures that are available in the workplace. These requirements may include – company policies and procedures, work instructions, product quality specifications and legislative requirements.
Service information may include – technical information for a vehicle, machine, or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

Outcomes and performance criteria

Outcome 1

Plan for the safe recovery of a 4WD vehicle.

Performance criteria

- 1.1 Plan includes location and condition of the vehicle, and the recovery vehicle where applicable.
- 1.2 Plan specifies recovery equipment suitable for the recovery.
- 1.3 Plan includes recovery calculations.
- 1.4 Plan includes procedures to maintain safety of personnel involved and to prevent damage to vehicles, equipment and the environment.

Outcome 2

Safely recover a 4WD vehicle.

Performance criteria

- 2.1 The 4WD vehicle is safely recovered following the recovery plan.
